OFFICE ORDER

1. On the recommendation of DSSSB, Sh. Manoj Nath S/o Sh. It appears that he is not interested to join the post of Nursing Officer offered to him.
4. Now, therefore, the offer of appointment in r/o Sh. Manoj Nath S/o Sh. Sant Nath, Roll No. 12370903951, for the post of Nursing Officer under post code 03/18 hereby stands cancelled & no further communication in this regard shall be entertained by this Hospital.
